Ref: Board's Rates Circular No. 60 of 2009 and its Corrigenda; 15 of 2010 and its Corrigenda; 23 of 2013; 25 of 2013 and its Corrigenda; 26, 27 & 28 of 2013; 31 of 2014 and its corrigenda, 26 of 2015 & 25 of 2017; 22 of 2019 and its addendum; 24 of 2020; 29 of 2021 and 10 of 2022.

- 1. Reference above, in terms of Rates Circular No. 10 of 2022, sanction was accorded to grant rebate in freight for Caustic Soda/ Caustic Soda Lye/ Caustic Soda Liquor; Alumina; Furnace Oil; and Bulk Cement when loaded and transported in privately owned wagons for the period beyond 31.03.2022 and up to 31.03.2023.
- 2. Matter has been reviewed and it has been decided by the Competent Authority to revise the percentage of rebate as under:

- 3. However, grant of rebate will be subject to amendment in the existing agreement with the respective wagon owner(s) clearly mentioning the total number of privately owned wagons; their ownership; their codal life; and stipulation regarding ownership of wagon after completion of codal life of wagon.
- 4. The rebate will be continued till the codal life of the wagons and will be granted only on mechanically and functionally fit wagons. Any new wagon should only be procured under any new prevalent scheme(s).
- 5. All other terms and conditions as stipulated in above referred Rates Circulars will continue to apply unchanged.

- 6. These instructions shall come into force with effect from 01.04.2023 and shall remain valid till 31.03.2024.
- 7. This issues with the concurrence of Finance Directorate of the Ministry of Railways.
