Rules and Regulations of Annual Membership Subscription

An admission fee of Rs. 25,000/-* shall be paid with the form of application for membership by each company. Annual subscription based on the combined yearly consumption of indigenous and imported Coal, Coke, Petcoke etc. shall be paid by each member. The consolidated subscription shall be as follows:

i) Annual consumption upto 2.50 Lac tonnes	Rs. 30,000/-
ii) Annual consumption above 2.50 Lac to 4.50 Lac tonnes	Rs. 40,000/-
iii) Annual consumption above 4.50 Lac to 7.00 Lac tonnes	Rs. 50,000/-
iv) Annual consumption above 7.00 Lac to 10.00 Lac tonnes	Rs. 60,000/-
v) Annual consumption above 10.00 Lac to 15.00 Lac tonnes	Rs. 85,000/-
vi) Annual consumption above 15.00 Lac to 20.00 Lac tonnes	Rs. 1,10,000/-
vii) Annual consumption above 20.00 Lac to 25.00 Lac tonnes	Rs. 1,50,000/-
