



1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes are prescribed.
2. In terms of reference (i) above, General Manager is empowered to approve running of CC+8 routes operations. Other conditions and procedures remain same.
3. Western Railway has forwarded a proposal with due approval of General Manager to include the following route in the list of already identified CC+8 routes as below:
SABARMATI 'D'Cabin – BOTAD (SBID–BTD) of BVP Division over Western Railway.
4. Sanction of the Competent Authority is hereby accorded to include the above-referred route of Western Railway in the list of already identified CC+8 routes.
5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
7. These instructions shall come into effect from 31.03.2023 and shall remain valid till further advice.
